THOUGH SCHOOLS REMAINED CLOSED BECAUSE OF THE PANDEMIC, IN JULY OF 2020, WE WERE ABLE TO RE-OPEN OUR MOBILE DENTAL CLINIC AT OUR OFFICE IN FERNDAL BY FOLLOWING THE CDC MANDATED EXTRA PRECAUTIONS. PRASAD CDHP DISTRIBUTED TOOTHBRUSHES TO CHILDREN AND PRODUCED FIVE DENTAL HEALTH EDUCATION VIDEOS THAT HAVE BEEN SHARED WITH SCHOOL NURSES AND PUBLIC HEALTH PROGRAMS IN SULLIVAN COUNTY. IN 2020, PRASAD CDHP DENTAL CLINIC PROVIDED 632 VISITS AND PERFORMED 2,137 DENTAL PROCEDURES. IT WAS NOT POSSIBLE TO DELIVER IN-PERSON DENTAL HEALTH EDUCATION CLASSES AT THE SCHOOLS. PRASAD CHILDREN'S DENTAL HEALTH PROGRAM OPERATED A HOTLINE FOR CHILDREN'S SERVICES.

AT PRASAD CHIKITSA IN THE TANSA VALLEY IN INDIA, THE IMPACT OF COVID-19 WAS OVERWHELMING. WE HAVE HAD TO SHUTTER OR REDUCE MANY OF OUR ESSENTIAL PROGRAMS WHILE FOCUSING ON HEALTH CARE, FOOD SECURITY, AND ECONOMIC RECOVERY.

PRASAD CHIKITSA PROVIDED VITAL MEDICAL SERVICES, PRODUCED AND DISTRIBUTED MORE THAN 1,300 FACE MASKS TO COMMUNITY MEMBERS, DELIVERED NEARLY 3,600 FOOD PACKAGES TO 2,240 ADIVASI FAMILIES, AND PLANTED MORE THAN 7,000 TREES. ALSO, 3,000 WOMEN PARTICIPATED IN SELF-HELP GROUPS. PRASAD CHIKITSA PROVIDED 32,000 MEDICAL VISITS.
